# What is happening now?

# The colonialism repeats itself...

- While many developing countries adopt digitalization agenda, they do not have the capacity to effectively navigate their system within this context yet.
  - Digitalization means → more and much more data collected
  - Data on populations have been and will be collected, with or without consent, then it will be used by those who have access to it or who have the capacity to analyze it.
    - Example, our mobile phone number has been given to a Gaming business/micro finance institutions...
  - The owner of the data do not know what data were collected/stolen and/or did not know what those data will be used for.

# What should be the ways forward?

- Digitalization is not bad – it is for the development of the globe. However, measures should be taken to ensure equitable benefits of the digitalization.
- Many developing countries received financial and technical support to implement the digitalization agenda, however, most are at the stage of data collection.
  - What do to with the huge amount of data collected? → Machine learning (AI)
  - Some organization → produce health and other statistics for all the countries, even the country itself does not know where the statistics came from.
- Equity should be applied to data harvesting as developing countries need more capacity building in data science so that they could optimally use their own data and equitably share it for the benefit of global society.
